

SUMMARY ANNUAL REPORT

For HEAVY & GENERAL LABORERS' LOCAL UNIONS 472 & 172 OF NJ ANNUITY PLAN

This is a summary of the annual report for Heavy & General Laborers' Local Unions 472 & 172 of NJ Annuity Plan, EIN 22-2331070, Plan No. 001, for period January 01, 2018 through December 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The plan has contracts with The Prudential Insurance Company of America and The Union Labor Life Insurance Co. The total premiums paid for the plan year ending December 31, 2018 were \$0.

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$46,678,192. These expenses included \$4,240,588 in administrative expenses, \$40,253,844 in benefits paid to participants and beneficiaries, and \$2,183,760 in other expenses. A total of 13,193 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,048,906,898 as of December 31, 2018, compared to \$1,050,029,080 as of January 01, 2018. During the plan year the plan experienced a decrease in its net assets of \$1,122,182. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$45,556,010, including employer contributions of \$72,460,230, realized losses of (\$10,825,403) from the sale of assets, and losses from investments of (\$16,078,817).

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
